CALL FOR APPLICATION OF REGULAR FOREIGN STUDENT (02/2024)

Program recommended by CAPES in 2004 - Master's degree Program recommended by CAPES in 2010 - Doctorate

The Universidade Federal de Pelotas (UFPel) in compliance with the *Stricto Sensu* Regiment of the Dean of Research and Graduate Studies and the Coordination of the Graduate Program in Microbiology and Parasitology discloses to the public, for the knowledge of interested parties, the call for application of foreign candidates to the program, under the terms established in this Notice.

I-GENERAL INFORMATION

The language of the courses taught at the PPGMPAR is Portuguese, but students can take advantage of courses taught in another language at UFPel or other institutions, requesting the proper use, which will be analyzed by the PPGMPAR collegiate. Proficiency in Portuguese is not required for admission to the PPGMPAR. Foreign students will be able to defend a thesis written in Portuguese, English or Spanish. The student must take the Portuguese for Foreigners (PPE) course in all semesters offered by UFPel.

II-REGISTRATION

Registration for the Selection Process for the Graduate Program in Microbiology and Parasitology at UFPel will be open from september 23, 2024 to october 20, 2024, exclusively by email (parasitologia@ufpel.edu.br). Foreign candidates must have Masters' degree, in the areas related to the program (Microbiology, Parasitology Biological Sciences, Health Sciences, Veterinary Sciences, and Multidisciplinary Sciences), at the discretion of the Program Coordination. It is mandatory to fill out the Application for Registration (Form 1) attached to this Notice. The Application for Registration must be accompanied by the following documents, which may be in Portuguese, Spanish or English:

- 1. Copy of the Graduation and Master's Diploma.
- 2. Copy of the Academic Transcript of the Undergraduate and Master's Course.
- 3. Curriculum Vitae (with scanned copy of proof documents). All curriculum documents must be sent attached in a single PDF file.
- 4. Copy of the Passport or official identification document.
- 5. Letter of intent. Documents must be sent by email (parasitologia@ufpel.edu.br) by 11:59 pm on october 20, 2024. Applications sent after that date will not be accepted.

No candidate may participate in any stage of the selection process if there is a pending on the documentation required for the application.

III- SELECTION

The Program Selection Exam will be carried out through the evaluation of the Curriculum Vitae and proof documentation.

IV-ASSESSMENT CRITERIA

The Evaluation Committee will evaluate the Curriculum Vitae using the FORM 2 found on the Program webpage (https://wp.ufpel.edu.br/ppgmpar/).

In CLASSIFICATION: The final grade will be calculated based on the grade obtained in the curriculum examination.

Total – 06 vacancies for doctorate's degree

V - CLASSIFICATION

The results will be published on the Program webpage. Publication date: november 07, 2024.

Candidates may individually request access to the grade through the Program e- mail.

VI-APPEAL

Appeal to the result of the approval of the applications and of any of the phases of the evaluation must be forwarded by e-mail to the Evaluation Committee within a period of up to 72 hours from the publication of the results. The analysis of the resources will be carried out by the Collegiate of the PPGMPAR taking into account the application of the criteria set out in this Notice, as well as the applicant's access to information and documents produced by it and, once the need has been demonstrated and justified interest, by any other candidate in the contest, in all stages of the selection process.

VII- FINAL PROVISIONS

Candidates classified up to the maximum number of vacancies will be entitled to enrollment, according to the Research Line and/or Area of Concentration chosen by the candidate. It is not mandatory to fill in the number of vacancies offered by the Program. At the moment, a language proficiency test will not be required, which can be taken during the year of entry into the Program. Enrollment in the process implies full acceptance of all terms issued in this Notice. What is not provided for in this Notice follows the Regulations of the Stricto Sensu Courses of the Dean of Research and Graduate Studies and the General Regulations of the UFPel.
